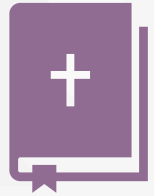


# HUMAN TRAFFICKING

### What does the Bible say?

Since, therefore, the children share flesh and blood, God likewise shared the same things, so that through death God might destroy the one who has power over death, that is, the devil, and free those who all their lives were held in slavery by the fear of death. For it is clear that God did not come to help the angels, but the descendants of Abraham. **(Hebrews 2:14-16)**



Woe to him who builds his house by unrighteousness, and his upper rooms by injustice; who makes his neighbors work for nothing, and does not give them their wages. **(Jeremiah 22:13)**

But those who want to be rich fall into temptation and are trapped by many senseless and harmful desires that plunge people into ruin and destruction. For the love of money is a root of all kinds of evil, and in their eagerness to be rich some have wandered away from the faith and pierced themselves with many pains. **(1 Timothy 6:9-10)**

Speak out for those who cannot speak, for the rights of all the destitute. Speak out, judge righteously, defend the rights of the poor and needy. **(Proverbs 31:8-9)**

### What does The United Methodist Church say?

We deplore all forms of commercialization and exploitation of sex, with their consequent cheapening and degradation of human personality. To lose freedom and be sold by someone else for sexual purposes is a form of slavery, and we denounce such business and support the abused and their right to freedom.

**(Social Principles ¶161.I)**

We call on United Methodists...to actively champion anti-slavery efforts by petitioning the United Nations and the legislative bodies of all countries in which The United Methodist Church has an organized ecclesiastical structure, to demand the freeing of all persons subjected to modern-day forms of enslavement and bonded labor. **(2016 Book of Resolutions, #6032, "Eradicating Modern-Day Slavery")**

United Methodists have worked to eradicate the many forms of violence that destroy the integrity of individuals, families, communities, and nations. People of faith must work to change attitudes, beliefs, policies, and practices at all levels of society that dehumanize and promote the exploitation and abuse of women and girls. **(2016 Book of Resolutions, #3427, "Eradicating Sexual and Gender-based Violence")**

# HUMAN TRAFFICKING

### What do the facts say?

- An estimated 40.3 million people are in modern slavery, including 24.9 million in forced labor and 15.4 million in forced marriage<sup>1</sup>.
- Women and girls are disproportionately affected by forced labor, accounting for 99% of victims in the commercial sex industry, and 58% in other sectors<sup>2</sup>.
- Globally, forced labor and sex trafficking generates \$150 billion in profits annually with two-thirds of that total coming from commercial sexual exploitation<sup>3</sup>.
- In 2017, an estimated 1 out of 7 endangered runaways reported to the National Center for Missing and Exploited Children were likely child sex trafficking victims<sup>4</sup>.
- 156 goods from 77 countries are produced by forced and child labor<sup>5</sup>.
